

DERMAL SENSITIZATION STUDY OF FORMALDEHYDE SOLUTION IN GUINEA PIGS Study No. 309 Test Article No. 100

SUMMARY

FORMALDEHYDE SOLUTION at a concentration of 15% was applied in 0.5 ml doses to the upper left quadrant of the backs of ten guinea pigs once per week during an induction period of 3 weeks. Two and 3 weeks following the induction period, the lower left quadrant of the back of ten treated guinea pigs and five control guinea pigs was challenged with 0.5 ml of the dosage formulation. All guinea pigs were scored for edema and erythema 24 and 48 hours following administration of each challenge dose.

None of the controls and ten of ten treated guinea pigs exhibited positive Draize erythem atous reactions greater than one during the study. No edematous reactions were observed in either group. The median score obtained in the control group was 0.0 and the range of median scores obtained in the treated group was 0-2. Four of the guinea pigs treated with test article had Draize erythem a scores in excess of 2.

DERMAL SENSITIZATION STUDY OF FORMALDEHYDE SOLUTION IN GUINEA PIGS

I. INTRODUCTION

The purpose of this study was to determine the dermal sensitizing capability of FORMALDEHYDE SOLUTION in guinea pigs following repeated skin application.

II. MATERIALS AND METHODS

- a. <u>Test Article</u>: FORMALDEHYDE SOLUTION (Sargent Welch, lot no. KTKH) was received April 4, 1981. The test article is a clear liquid. The test article was stored in the original container at room temperature (approximately 22°C).
- b. <u>Dosage Formulation</u>: The dosage formulation was 15%. It was found during a preliminary study in guinea pigs, that this concentration produced a Draize score of 1 or less in control guinea pigs, receiving a single application.
- c. Animals: Adult male Hartley Guinea Pigs weighing approximately 325 g, were purchased from Elm Hill Breeding Labs, Chelmsford, MA for use in this study. All guinea pigs were held in quarantine for approximately 1-1/2 weeks following receipt (7/16/81) and examined carefully to insure their health and suitability as test subjects. Guinea pigs selected for the study were identified by a unique numbered metal tag inserted through the pinna of the right ear and by a cage card.
- d. <u>Food and Water</u>: Guinea Pig Chow 5025 (Ralston Purina Co., St. Louis, MO) and water supplied from a reverse-osmosis purifier by an automatic watering system were available ad libitum.
- e. Environment: The individual stainless steel cages measured 25.0 x 17.8 x 41.2 cm and conformed to the upper limit weight range recommended in the Guide for the Care and Use of Laboratory Animals, DHEW, (NIH) No. 78-23. Deotized animal cage board (DACB, Upjohn Company, Kalamazoo, MI) was provided beneath the suspended cages. Air conditioned animal rooms were maintained at approximately 22°C and 40% relative humidity. Fluorescent lighting was provided on the basis of a 12 hour diurnal cycle.

f. Method:

l. Animals: Fifteen male guinea pigs were used in this study. Ten guinea pigs were treated and five guinea pigs were used as controls.

2. Skin Preparation: Twenty-four hours prior to test article application the backs of the treated guinea pigs were clipped free of hair. The upper left quadrant was clipped for the induction applications and the lower left quadrant was clipped for the challenge applications. Hair from the lower left quadrant was clipped from the backs of the control guinea pigs 24 hours prior to the challenge applications.

3. Dosing:

- a) <u>Induction</u>: A 0.5 ml quantity of the dosage formulation was applied to the upper left quadrant of ten guinea pigs once/ week for a period of 3 weeks beginning on July 28, 1981. The test article was covered by a 3/4" x 1" patch (Webril^R Appli-Pad, the Kendall Co.), held in place with impermeable plastic tape (Blenderm^R, 3 M Company) and elastic adhesive bandage (Elastoplast^R, Beirsdorf, Inc.). All wrapping materials were removed 6 hours after each application.
- b) Challenge: Two weeks following the administration of the last induction phase dose (8/26/81), a 0.5 ml quantity of the dosage formulation was applied to the lower left quadrant of the back of the ten treated and the five previously untreated control guinea pigs. The test article was covered by a 3/4" x 1" patch, (Webril^R Appli-Pad, the Kendall Co.) held in place with impermeable plastic tape (Blenderm^R, 3M Company) and elastic adhesive bandage (Elastoplast^R, Beirsdorf, Inc.). All wrapping materials were removed 6 hours after each application. A second challenge dose was administered in an identical manner 1 week later (9/2/81).
- 4. Skin Examination: Twenty-four and 48 hours after removal of each challenge patch, the test sites were graded for edema and erythema using the method of Draize (Appendix I). Guinea pigs were clipped if necessary prior to scoring.
- 5. Observations: All guinea pigs were observed daily for mortality and morbidity.
- 6. Body Weights Body weights were not measured.
- 7. Animal Disposition: After the final observation September 4, 1981, the guinea pigs were sacrificed humanely and discarded without necropsy.

g. <u>Evaluation</u>: A reaction with a Draize score of 2 or greater in the treated animals is considered a positive reaction. The concentration of test article used was intended to produce a Draize reaction of 1 or less in the control animals.

III. RESULTS

- a. Mortality: No deaths were observed during the study.
- b. Skin Effects: The individual erythema and edema scores (Appendix II) are summarized in Table I. None of the controls and ten of ten treated guinea pigs exhibited a positive reaction at least once during the study. A total number of 19 positive scores were obtained in the treated group. The range of individual erythema scores obtained in the control and treated groups were 0 and 0-4, respectively. Similarly, the range of median scores obtained were 0 and 0-2, respectively. No edema was observed in any guinea pig.

IV. EVALUATION

The erythem a scores for the test article exceeded the comparative control scores at every observation interval. Four of the guinea pigs treated with the test article had Draize erythem a scores of 3 or greater.

V. QUALITY ASSURANCE

Laboratory operations were inspected on August 4, 20 and 26, 1981. The final report was audited on January 21, 1982. All inspections and audits were performed by Josephine M. Reed. Raw data generated during the course of this study will be retained in the IITRI Life Sciences archives as specified by government regulations.
