Generic Name: Fluorinated Aliphatic Alcohol

This letter is to inform you of the results of a recently conducted acute oral toxicity study (up-and-down method) in rats with the above referenced substance.

The test substance was administered neat by oral gavage to 1 fasted female rat at a dose of 175 mg/kg, to 3 fasted female rats at a dose of 550 mg/kg, to 4 fasted female rats at a dose of 1750 mg/kg, and to 2 fasted female rats at a dose of 5000 mg/kg. Death occurred in 2 rats dosed at 1750 mg/kg (1 found dead, 1 sacrificed *in extremis*) and in both rats dosed at 5000 mg/kg (both found dead). The oral LD₅₀ is 1750 mg/kg.

One surviving rat dosed at 1750 mg/kg exhibited lethargy on the day of dosing and high posture up to 6 days after dosing. The other surviving rat dosed at 1750 mg/kg exhibited ataxia, lethargy, and high posture on the day of dosing. Another rat dosed at 1750 mg/kg exhibited ataxia on the day of dosing, hyperreactivity 2 days after dosing, high posture up to 2 days after dosing, and excessive vocalization 2 days after dosing. This rat was moribund and was sacrificed *in extremis* 3 days after dosing. The remaining rat dosed at 1750 mg/kg exhibited high posture the day of and day after dosing, lethargy 1 and 2 days after dosing, and leaning as well as ataxia 2 days after dosing. This rat was found dead 2 days after dosing. One rat dosed at 5000 mg/kg exhibited ataxia, lethargy, and high posture on the day of dosing and was found dead the day after dosing. The remaining rat

dosed at 5000 mg/kg was found dead on the day of dosing. No effects were observed in animals treated with 550 mg/kg or lower doses.

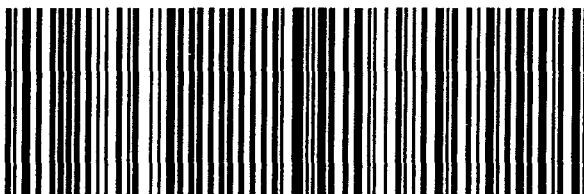
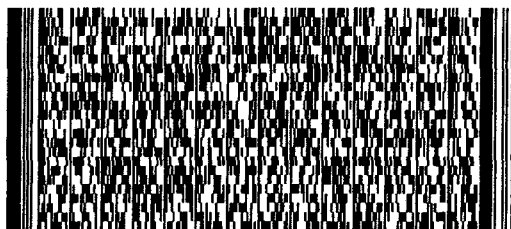
